PAYMENT # 1 – Registration deposit \$400 must be paid directly to World Shibori Network-USA

PAYMENT # 2 – ¥228,500 due Feb 2, 2014 - must be paid to NTA

Payment 2 is 50% of the 457,000 JPY balance. REMIT TO: Nippon Travel Agency (NTA) in Tokyo. Wire transfer or credit card, no checks.
